For Your Own Safety

1. Thank you for buying this Duel Fan Heater. Please read all instructions before using the fan heater.
2. Only connect the fan heater to a single-phase socket with a main voltage as specified on the rating plate.
3. Do not leave your home while the appliance is in function. Ensure that the switch is in OFF ("O") position and the thermostat is in minimum position. Always unplug the appliance.
4. Keep combustible material such as furniture, cushions, bedding, paper, clothes, curtains etc. At least 100cm away from the fan heater.
5. Do not hang anything on or in front of the fan heater.
6. Always unplug the heater when not in use. Do not pull the cord to unplug the heater.
7. Keep the air inlet and outlet free from objects, at least 100cm in front and 50cm behind the heater.
8. Do not install the heater right below a socket.
9. Do not let animals or children touch or play with the fan heater. The air outlet gets hot during operation (more than 80°, or 175F).
10. Do not use this fan heater in the immediate surroundings of a bath, a shower or a swimming pool.
11. Do not use the fan heater in the rooms with explosive gas or while using inflammable solvents, varnish or glue.
12. If the cord of this appliance is damaged discontinues use of this product and contact the manufacturer for further instructions.
13. Keep the fan heater clean. Do not allow any objects to enter any ventilation or exhaust opening as this may cause electric shock, or fire or damage to the heater.
14. This appliance can be used by children aged from 8 years and above and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved. Children shall not play with the appliance. Cleaning and user maintenance shall not be made by children without supervision.

Warnings

- Do not use the appliance in the vicinity of showers, bathtubs, washbasins, swimming pools, etc.
- Do not use the heater to dry your laundry. Never obstruct the intake and outlet grills(danger of overheating).
- The heater must be positioned at least 1 metre from furniture or other objects.
- The appliance should be installed so that the switches and other controls cannot be reached by persons using the bathtub or the shower.
- If the supply cord is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified person in order to avoid a hazard.
- The appliance must not be positioned directly underneath a fixed power point.
- Do not use the appliance in rooms less than 4m² area.

The heater is fitted with a safety device that will switch off the heater in case of accidental overheating (e.g. obstruction of air intake and outlet grills, motor turning slowly or not at all). To reset, disconnect the plug from the power for a few minutes, remove the cause of overheating then plug the appliance in again

Using your Heater

INSTALLATION

The appliance requires no installation; it should be used solely as a portable appliance.
Portable appliances are not suitable for use in a bathroom.

OPERATION

- Turn the thermostat knob (right) in a clockwise direction until it reaches the maximum setting.
- Summer service (ventilation only): turn the knob to setting 'x'.
- Heating at reduced power: turn the knob (right) to setting '•' (1000W).
- Heating at full power: turn the (right) to setting '••' (2000W)
- Switching off: turn the knob (left) to setting 'O'

REGULATING THE THERMOSTAT

When the room has reached the required temperature turn the right thermostat knob (where included) in an anti-clockwise direction up to the point where the appliance switches off and not beyond. The temperature fixed in this way will be automatically regulated and kept at a constant level by the thermostat.

CLEANING AND MAINTENANCE

Before cleaning always remove the plug from the electrical socket.
Clean the air inlet/outlet grilles frequently.
Never use abrasive powders or solvents.

Heater Guarantee

HEATER GUARANTEE

De Vielle guarantees that this heater will be free from defects in workmanship and materials for a period of 2 year from the date of purchase. Any product found to have defects in workmanship or material within the period of this guarantee will be replaced free of charge.

The conditions of this guarantee are as follows:

- A) The product has been properly maintained.
- B) Defects or damage due to normal wear and tear, accident, misuse, or interference are not included.
- C) The product is made available for inspection, together with proof of purchase. NB. This guarantee does not affect your statutory rights.

PLUG REPLACEMENT

If the plug is damaged and requires replacement, follow the wiring instructions supplied with the new plug.

- The blue wire must be connected to the terminal marked with the letter N or coloured black.
- The brown wire must be connected to the terminal marked with the letter L or coloured red.
- A 13 amp plug (BS 1363) fitted with a 13 amp fuse (BS 1362) must be used.

NOTE: THIS UNIT IS DOUBLE INSULATED AND THEREFORE DOES NOT REQUIRE AN EARTH CONNECTION.
